


AGREEMENT FOR DISMISSAL





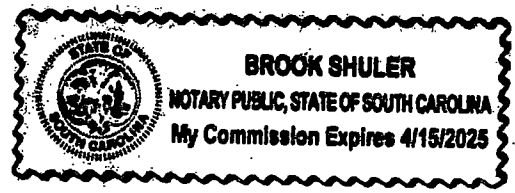
