ISSUES FOR REVIEW

1) United States Magistrate F. McDonald's CONCLUSION AND RECOMMENDATIONS dated Octobe 21, 2015 and November 30, 2015 respectively.

2) United States Senior Judge M. Herlong Jr.'s ORDERS dated November 17, 2015 and December 21, 2015 and August 24, 2016 respectively.

3) Whether attorneys Wilson S. Sheldon and J. Adam Russell in this civil case they are legally able to defend Defendants Wilson Jones Carter & Baxley P.A., and their attorney Wesley J. Shull.

Attorney Wilson S. Sheldon himself own Wilson Jones Carter & Baxley P.A. Therefore, Attorney Wilson S. Sheldon also is a defendant and the subject of allegations made against him for Health Care Misconduct, Judicial Misconduct, Fraud, Conspiracy. Appellant Zulveta will request that joined State and Federal criminal investigations be conducted against said Law Firm. These investigation could generate criminal charges and successful prosecution against Wilson S. Sheldon and his Wilson Jones Carter & Baxley P.A., Law firm. Therefore, attorney Wilson S. Sheldon and J. Adam Rusell they have no legal authority to conduct these cases.

4) Whether defendants TC Unlimited, Inc., and Tim Case's attorney CLAWSON and STAUBES , LLC attorney Timothy A. Domin, they are legally able to conduct these cases in behalf of a company that a) defraud taxpayers, b) pay no taxes c) offer employment and hire undocumented immigrants in violation of the law, d) in retaliation for filing an injured worker claim in The South Carolina Workers Compensation terminated their worker Appellant Zulveta, e) for the purpose of cover up their unlawful activity above defendants introduced in lower court swear Affidavit of Perjury that contradict evrything that the defendants verbally said and documented stated to their Nurse Case

Manager Angel Bennett, to the MOVANTS, and me, Appellant Zulveta. That he in fact terminate me.

5) Whether HAYNSWORTH SYNKLER BOYD, P.A., attorneys Kenneth N. Shaw and J. Ben Alexander for Defendants Steadman Hawkins Clinic of the Carolinas (Greenville Hospital System, GHS) and Curtis Elliot, MD, they are legally able to conduct these civil cases since Dr. Baumgarten from said hospital facility introduced in court a fraudulent Physician Statement with obvious appearance of being bribed by Wilson Jones Carter & Baxley. Dr. Baumgarten took an undisclosed amount of money payment for said medical consult with THE MOVANTS. As result, this medical consult produced a fraudulent Physician Statement Form 14B legally by court order entitled THE MOVANTS to every single of their reliefs they have requested. Therefore, this is Bribery.

6) Whether defendants State Automobile Mutual Insurance Co., Robert P. Restrepo, Jr., and Stephen R. Bruner's attorneys GALLIVAN, WHITE & BOYD, P.A., with their history of defaults and unlawful procedures in conjunction with Common Pleas' Non Jury Coordinator Steve Lopez and Clerks Shawn, and Sandra, and Dale, in and out of court can be able to proceed this case in behalf of Defendants above whom also they have allegations of Fraud and Conspiracy among other things pending in this civil case.

5) Whether TURNER PADGET GRAHAM and LANEY P.A., attorney Eric Englehardt for Defendants Philpot Law firm, PA and Irvin H. Philpot, are legally able to proceed this case having Defendant Irvin H. Philpot, III and Philpot Law Firm P.A., conducted obscure maneuvers in The South Carolina Workers Compensation Commission obstructing themselves from being relieved from his obligation as my attorney and also their passive representation to the point that Appellant Zulveta had to do their job appealing to THE MOVANTS in order to obtain a medical appointment for a second opinion, and other things. This is judicial misconduct, fraud

6) Whether lower court exceed his discretion regarding Orders above.

7) Whether THE MOVANTS' fraudulent civil cases could be putted to an end and all reliefs Appellant Zulveta requested be granted by this Honorable Court of Appeals.

8) According to their attorneys Steadman Hawkins Clinic of the Carolinas is a name that Greenville Hospital System use for one of their brand. To this point Appellant Zulveta has no reason to believe nothing they said. I have made researches and nowhere to find or nobody to claim as owner of this name that many, many clinics have. Therefore, leave Steadman Hawkins Clinic of the Carolinas listed and add Greenville Hospital

System as defendant amended as well as amend Curtis Ellison which is correct name.
Remove Curtis Elliot.

9) Introduction in this court of copy of Exhibits certified letters forwarded last year to Bob Taylors City Council and I pulled unsigned out of my Flash Drive and after I signed as November 22, 2016 instead of November 22, 2015. It was a mistake I made.

10) Appellant Zulveta was not aware that my letters have been construed as Notice of Civil Case No.: 16-2078 has been opened. I can not respond to a number I did not know exists. Therefore, Appellant Zulveta started Civil Case No.: 16-2078 with wrong number addressed in my letters.

11) Joinder of all defendants and case mentioned above. On 09/16/2016 In Greenville District Court Appellant Zulveta filed a Notice of Intention to bring Charter Communications LLC to federal court. They are aware I intend to join them in federal court with THE MOVANTS as personal and ancillary due to their connection Greenville Hospita System, Gallivan White & Boyd, Wilson Jones Carter & Baxter, P.A., The Hills, The Stiwells, The Campbell, Chairman Beck, Judge Ford from Simsonville with The Hills, and more much.

12) Early this year Appellant Zulveta filed Notice of Appeal Greenville Library System's Notice of Trespassing in 13th Greenville Common Court but it was rejected because I did not include \$150 to begin action. Appellant Zulveta decided to wait for an opportunity to collect requested money and file said appeal in court. Subsequently Appellant Zulveta learned that:

a) since the future Notice of Trespassing appeal would include names like Board of Trustees Chair Chace Campbell (1st Campbell's bias rendered ORDER), and Vice Chair attorney Allan S. Hill (1st Hill's bias rendered ORDER), Appellant Zulveta desisted to file appeal because, b) as usual presiding hearing would be conducted by Judge Garrison D. Hill (2nd Hill bias rendered ORDER), c) another alternative presiding Judge Robin B. Stilwell (1st Stilwell to render ORDER), d) had Appellant Zulveta appeal Circuit Court decision (as usual there are gonna be plenty of base for) then at the South Carolina Court of Appeals would have to face Judge H. Samuel Stiwell (2nd Stilwell), e) had Appellant Zulveta in the South Carolina Supreme Court's Office of the Disciplinary Counsel file a complaint against one of the public officials mentioned above then Assistant Disciplinary Campbell, Esquire, was there to render ORDER (2nd Campbell bias rendered ORDER), f) Appellant Zulveta defrauded out of my South Carolina Workers Compensation's injured worker's paycheck benefits, medical bills and medical

prescription unpaid, doctors after being bribed willing to sign fraudulent Physician Statement against injured worker(s) and destroy my case in behalf of THE MOVANTS above then I faced at the hearing Commissioner Michael Campbell (3rd Campbell bias rendered ORDER while in the process suppressed my evidences at his hearing in behalf of THE MOVANTS above), g) as result of unauthorized repairs work made in my car (Jeep) in 2014 North Hills Automotive (3rd Hill defrauding the community) after I told them that neither need that work nor requested please dismantled it, they decided against my will to abduct my car. I took them to court having their attorney above Library Vice Chair S. Allan Hill (repetition of name Hill making him the 4th time involved in fraudulent and defrauding the community activity and having Judge Ford in conjunction, h) Judge Ford disappeared my Motions, i) while in business suit and at Simpsonville Courthouse's hall he tried to get me arrested with no good reason for, so there was no arrest, j) after he being recused from my case replacing Judge Grayvol had to stop the hearing two of my filed motions I have at the hearing she did not have, k) at least I had a partial victory because North Hills Automotive a member of THE MOVANTS they can not explain how my car made to their garage with a dead battery. They have claimed that my car's battery was dead, that they putted a new an expensive battery and I must pay for because I am trying to defraud them. No even when they get caught lying THE MOVANTS can be beaten in South Carolina Judicial System. So while they engage in judicial misconduct and in the process getting help from others they are invincible and that is the idea they have and at least in South Carolina I agree with them, m) the proff is that after all of what happened above to Appellant Zulveta and make countless and well founded allegations against The Hills, now in the 25th of this month in 13th Circuit Greenville Common Court I have to assist a hearing of Dismissal with judge Stilwel, from a case that Judge Hill destroyed on January 25, 2015 with judicial ambush, bias, prejudice, in behalf of the Movants Gallivan White & Boyd in state court, n) if I survive this Dismissal then on January 07, 2016 to decide a trial that would be presided by judge Garrison Hill, o) Judges Hill and Stilwel both of them were member of Greenville Hospital System's Board of Director this long time disclosure no bother then to keep rendering bias and prejudice because by now they want retribution and I have to be taught a lesson for. Therefore, finalize the destruction of my case that is being defrauded by Charter of my reimbursement money. THE MOVANTS

13) In order to proceed these case as fraud no more requirement of introduction of court officials in Office of Disciplinary Counsel again. It goes for Civil Cases mentioned and future Introduction as persona and ancillary cases Charter Communications LLC and Greenville Library System. If this court send me back to South Carolina courts to get

to lower court as well as SC court of appeals, common pleas,

APPELLANT INFORMAL BRIEF

Workers' compensation laws were enacted so that the "employee receives the right to swift and sure compensation; the employer receives immunity from tort actions by the employee. This quid pro quo approach to workers' compensation has worked to the advantage of society as well as the employee and employer." *Parker v. Williams and Madjanik, Inc.*, 275 S.C. 65, 70, 267 S.E.2d 524, 526 (1980). The purpose of workers' compensation is to settle claims quickly and efficiently. *Id.* One of the ways the legislature sought to insure this result was by enacting statutes that require the exchange of medical information so that claims can be evaluated and settled in a timely manner.

The requisite fraud on the court occurs where "it can be demonstrated, clearly and convincingly, that a party has sentiently set in motion some unconscionable scheme calculated to interfere with the judicial system's ability impartially to adjudicate a matter by improperly influencing the trier of fact or unfairly hampering the presentation of the opposing party's claim or defense." *Aoude v. Mobil Oil Corp.*, 892 F.2d 1115, 1118.

This appeal arises from Appellant Zulveta's civil Case 6:15-cv-02880-HMH-KFM dated July 23, 2015 filed in the lower district court against all of the defendants mentioned above. a) it contains allegations of Fraud and Conspiracy (among others) against all of the Defendants mentioned above, b) after lower court divided them (See Appellant Zulveta's (#1-4 above) sometime through the appeal those mentioned above changed their mind and for their convenience they re-grouped, re-organized, c) as result, they called themselves THE MOVANTS and while pushing through their case all together filed with this Honorable Fourth Court of Appeals MOTION TO DISMISS APPELLANT'S ZULVETA'S CASE, d) while Appellant Zulveta was trying to put together all of them again where they belong because this is a Civil Class Action that squarely fix into RICO racketeering laws.

The matter is that Appellant Zulveta neither has recourse, nor resources, no proper

justice and if Appellant Zulveta is given any that judgment would be rendered under coercion, intimidation. This is unconstitutional. By now several high level of public official as well as court officials they are aware of what is going on and what THE MOVANTS are doing to the community. Nothing has been done but The Movants redouble of their unlawful activity and aggravating it with the misuse of law enforcement police officers for their own personal benefit.

14) South Carolina Workers Compensation Commission's Chairman T. Scott Beck and Commissioner Campbell suppressed evidences at their respective hearings.

15) At Simpsonville in behalf of Judge Ford and the Hills a police officer placed a deadly threat on me for messing with Judge Ford or leave the town. I filed a complaint in the police department over the subject.

16) At the library, at the courthouse, in street, everytime I have a legal issue with The Hills there were the police either to arrest me, or like at Common Pleas courthouse in where these two police officers who were there to initiate and escalate a provocation, according to their hostility and they did not behave like the ones down stair in charge of Corporal Mr. Braggs whom they are there to protect people and are respectful police officers to people.

17) Common Pleas Non Jury Coordinator Steve Lopez and Clerk Shawn tamper, disappear, no place in Roster my sensitive Motions, maneuvers with my Motions like July 12, 2016, February 04, 2016, and more.

18) Common Pleas Judges mentioned above they have a close relationship related to scheduled hearings between them and The MOVANTS' Gallivan White & Boyd P.A. Non Jury Coordinator Steve Lopez made this possible.

19) No more introduction of court officials on Disciplinary Counsel again in order to proceed with these case. If I go back to SC to get justice any justice given by any lower court involved in these cases it would a verdict given under coercion, intimidation. That is unconstitutional. By now some important public official are being informed of these misconduct and nothing has been done but THE MOVANTS above redouble their judicial misconduct and misuse of police law enforcement at every level. Appellant Zulveta has exhausted all remedies in SC and by now evidently all of my cases are being destroyed. I just trying to bring to the attention the community's suffering defraudation.

Introduce exhibits against the movant in the lower court and this court I have provide

legal acknowledgement doing researches to file this kind of case, nor money to pay for an attorney. THE MOVANTS above are defrauding South Carolina's communities. In the process they defraud state and federal government through Medicaid, Medicare, Social Security, government benefit programs. They are doing good job putting individuals of the community into dependency of said government programs.

While in the process in behalf of South Carolina's communities they are putting the burden to pay the bills for those programs and government paid benefits on the same communities' taxpayers.

While in the process said facility like Greenville Hospital System, and Greenville Library System (couple of THE MOVANTS' stronghold) these facility since are created to help the community they are receiving some kind of benefit out of state of federal programs. It could be something as simple as TAX BREAK. Therefore, THE MOVANTS no only defraud Appellant Zulveta and South Carolina's communities but also, the federal government of their tax and contribution to the community. Had this INITIAL BRIEF and appeal be accepted a paralell to this civil case Appellant Zulveta would request.

While in the process THE MOVANTS above as powerful insurance carrier, as powerful local employer, as powerful SC State's state local facility hospital, and their high profile local attorneys like Defendant above Wilson Jones Carter & Baxley, PA, and Philpot Law Firm, and P.A, Gallivan White & Boyd their associate discovered after this case had filed, their doctors and attorneys they all enriching themselves. In detriment of the community.

On July 23, 2015 I filed this civil action having them as whole one. Subsequently, Judge Herlong, Jr.'s ORDER granted their dismissal and got them separated. Also, they made a comeback, joined in appeal TC Unlimited Inc., and Tim Case, called themselves: The Movants.

Having filed Motions on time Appellant Zulveta did not agree that by order of the clerk of court case 15-2561 with this court of appeals had been closed on 8/18/2016. For this purpose late afternoon on October 03, 2015 Appellant Zulveta placed a call to this Circuit of Court and made inquiry about 15-2561 case status and Motions I have filed. As usually lately could not get what I thought was my case manager Joy Moore nor anyone else connected to the phone nor answer voice mail left behind but the Operator made me aware that I have an open pending appeal civil case No.: 16-2078 that at the

time Appellant Zulveta did not know exists and also, the name of my new manager whom immediately I called and afterward he identify himself as Michael Radday my new manager which he is also is listed as Deputy Clerk. He had over 30 minutes of phone conversation in which he assured that on August 21, 2016 the clerk of court sent me INFORMAL BRIEF with documents of IFP and that I have been sending Motions to them so I must have to be aware of the existence of this new civil case No.: 16-2078 is open. Case Manager asked me if I have a new mailing address and upon my confirmation Mr. Radday brought the subject that Appellant Zulveta hasn't have received said information because I had changed mailing address and my former Case Manager Joy Moore did not know it at the time. Confirming their statement from Docket Sheet I retreated Notice of case No.: 16-2078 has been opened. Case Manager Michael Radday forwarded me said Clerk of Court's Notice and states that: "I had included a new address but that information hasn't been updated on my docket"

On October 05, 2016 my former Case Manager Joy Moore said similar statement regarding I must have to know Case No.: 16-2078 exists because they are receiving my Motions, which is true but my Motions bear Civil Case No.: 15-2561. After August 21, 2016 only I received from Clerk of Court Patricia S. Connor's For the Court- By Direction dated September 29, 2016 ORDER of Denial Motion to Reopen the case. That was all of the information I had and that my appeal was closed on 8/18/2016.

Plaintiff Zulveta still preserving old mailing address P.O. Box 24892 Winston-Salem, NC 27114. Until yesterday there was no indication that a legal mail from this clerk of court was sent to my old mailing address.

Still, with ample time Case Managers Joy Moore and Michael Radday they were aware of both of my mailing address. Plaintiff Zulveta could not stop reaching the conclusion that this is the fingerprint, same pattern of judicial misconduct Greenville County Court 13th JUDICIAL at least at Clerk of Court level, in which clerk of courts, court reporter, and translator are involved at every of my civil cases. With names like Hill, Campbell, Stilwell, Gallivan White & Boyd, P.A., Wilson Jones Carter & Baxley, P.A., involved in judicial misconduct with THE MOVANTS above.

Therefore, Plaintiff moves this Fourth Circuit of Appeals into consideration that the official time of Appellant Zulveta having acknowledgment of No.: 16-2078 exists it is late afternoon October 03, 2016. Unlike my Case Managers Joy Moore and Michael Radday, the Phone Operator was the one who made Appellant Zulveta aware of this pending appeal. Prior to this occasion, I did not know this number exists.

Plaintiff Zulveta still preserving old mailing address P.O. Box 24892 Winston-Salem, NC 27114 I just open a new one while giving time the older one to still receiving unexpected letters. There is no indication that a legal mail was sent to neither of my mailing address.

Early this year for secure purpose I sent filed Motions to my former Case Manager Joy Moore until over the phone we had couple of strong disagreements over her firmly belief that Appellant Zulveta should not mention the name of The Governor of South Carolina Honorable Nikkie Haley in this civil case. Also that Appellant Zulveta should not introduce the name of SC Wokers Compensation Commission T. Scott Beck nor Commissioner Michael Campbell in this civil court of appeals. Having this motive my Case Manager Joy Moore refused to send me back copy of filed Motion clock stamped in the properly pre-paid-self-addressed envelope I had enclosed. Which filed Motions has names like at the time Presidential Candidate Ben Carson, a champion speaking about Health care Misconduct which Appellant Zulveta plans is to subpoena him hoping he would be more than glad to testify about his expertise regarding medical field and also, his expertise on the dozens of billions of dollars loss every year that the community and taxpayers are billed for and meanwhile having their premium healthcare insurance skyrocketing and being double beating down by associations like THE MOVANTS above.

Appellant Zulveta never met nor have any reason to doubt about the integrity of at the time this court of appeals Honorable Judge William B. Traxler, Jr. At the same time as a effort of abundant caution I stopped the filing of my Motions at this United States Fourth Court of Appeals because Honorable Traxler was a resident judge of the 13th Judicial Circuit, Greenville County, Greenville, SC, where mainly I have been having all judicial misconduct. His mere presence there along with Joy Moore conduct raised me red flag, caution. And anybody who felt offended for my reaching conclusion just put for a moment my shoes, which cases involved money, property, loss of job, lack of medical attention, judicial misconduct, and a lot of more.

Appellant Zulveta prays that this appeal would be taken by this Honorable Court of Appeals. This is a case of public interest. Everything Appellant Zulveta has said over the past two year is this year President's election Platform. They repeat to the nation what already Appellant Zulveta has said in these civil cases. They follow me because this is an Enterprise fraudulent operation that is well out of proportion that it has become an everyday of our defrauding values by associations like THE MOVANTS.

ISSUE 1.

SUPPORTING FACTS AND ARGUMENT

According to Commissioner Beck's Court Reporter Skylet Kean's INVOICE at Workers Compensation hearing date September 01, 2015 said Commissioner suppressed evidences that at the hearing injured worker Claimant Zulveta considered that you was a conflict of interest defending TC Unlimited and Tim Case from my claim.

That with ample time I requested a paid translator and pay for said motion. Commissioner Beck forced me instead to use Defendants translator.

That Motion for adjourn of hearing denial was bias that benefit THE MOVANTS.

That Commissioner Campbell suppressed my evidences from hearing date December 09, 2015.

That their Judicial Director Amy Brady tampered and suppressed Claimant Zulveta's Motions of Disqualify Commissioners Beck and Campbell from my case.

That she suppress Motion of Objection to Commissioner Campbell's Proposed Order.

That that were performer judicial misconduct and Health Care Misconduct that benefit the Movants.

ISSUE 2.

SUPPORTING FACTS AND ARGUMENT

According to court legal documents and affidavits based in own Tim Case's testimony and also Appellant Zulveta own personal account I being his former employee, a) TC Unlimited inc., and Tim Case for more than 20 years they run this multi million dollars enterprise which labor consist of 99% of undocumented immigrants who are not authorized to work in this country, b) over 22 employees most of they are illegal and undocumented laborers that Defendants TC Unlimited Inc., and Tim Case they use while in the process of exploit them, and enriching himself, at the same time he is an employer who takes away jobs from his own fellow citizens, c) based on his personal interest, defendants TC Unlimited, Inc., and their owner Tim Case they devalue working

wages while having undocumented immigrants working over 80 hours a week, d) no overtime is paid, e) almost minimum wage paid (\$8 an hour) for the operation of heavy and dangerous equipment that in lawful circumstances its operation's wage paid is over (\$22 an hour, f) at working area Defendants no implementation of state and/or federal regulation safety standards, g) Violation of OSHA and cause of my accident while working under this unsafe condition, h) in the process they purposely avoid pay taxes, i) defraud the taxpayers, j) defraud state and federal government, k) defraud the IRS.

TC Unlimited Inc., and Tim Case they run a fraudulent and illegal company that violates State's and Federal's Labor Laws.

For the purpose of enriching himself TC Unlimited Inc., and employer Tim Case also they violate United States Homeland Security's laws on Immigration. in addition, the security of the country while employee individuals from other countries which THE HOMELAND SECURITY neither has an idea of who they are nor information as simple as they are illegally living in this country. Therefore, CLAWSON and STAUBES , LLC attorney Timothy A. Domin for defendants TC Unlimited Inc., and Tim Case they are conducting a fraudulent case in this court of appeals. In which this Honorable Fourth Circuit Court of Appeals has personal and ancillary jurisdiction.

Among other thing defendants introduce sworn affidavit of perjury in a federal court, Incompetent to Stand at Trial Affidavit that sustain their case. Defendants "(1) knowingly made a (2) false (3) material declaration (4) under oath (5) in a proceeding before or ancillary to any court or grand jury of the United States.

18 U.S.C. 1621, outlaws presenting material false statements under oath in federal official proceedings. A second, 18 U.S.C. 1623, bars presenting material false statements under oath before or ancillary to federal court or grand jury proceedings. A third, 18 U.S.C. 1622 (subornation of perjury), prohibits inducing or procuring another to commit perjury in violation of either Section 1621 or Section 1623.

ISSUE 3.

SUPPORTING FACTS AND ARGUMENT

Wilson Jones Carter Baxley, P.A. forwarded me letter dated September 17, 2015 in which Dr. Baumgarten has been paid for having a meeting with attorney Wesley J. Shull regarding my medical condition.

Based on experience with attorney Shull and his Law Firm September 25, 2015 I wrote a letter to said doctor over my concern of his medical judgment be poisoned.

No avail. Fraudulent Physician Statement was issued out of said paid meeting.

Dr. Baumgarten was or is a Greenville Hospital doctor and medical provider of defendants above. Against the request from their own therapist Brad and Dr. Crumpler who sent written request to said doctor chose not to attend me, ignored my medical condition. Like Dr. Baumgarten, THE MOVANTS also ignored my request for medical attention only to six months later reappear at Commissioner Campbell 12/09/2015 hearing with a fraudulent Physician Statement that in behalf of the Movants above destroyed my case.

ISSUE 4.

SUPPORTING FACTS AND ARGUMENT

Gallivan White and Boyd, P.A., with their culture of defaults in state and federal court. a) while at the same time as an abuse of discretion for their purpose of their psychological judicial warfare against Pro Se they use as their landmark for their fraudulent activity in court this Honorable Fourth Court of Appeals decision rendered on: Charles Alan Wright & Arthur R. Miller, FEDERAL PRACTICE AND PROCEDURE & 2699 at 536-37; Tolson v. Hodge, 4th Cir. 1969) (court noted that there was nothing in the record to suggest that the non-defaulting party suffered any prejudice for delay, other than giving up the judgment to which she thought she was otherwise entitled)

This is the passport THE MOVANTS use to bypass Entry of Default placed on them in Greenville County 13th Circuit Common Pleas Court Civil Case No.: 2015-cp-23-05171 Charter Communication LLC attorney Gallivan White and Boyd, P.A. they filed Motion to Response Plaintiff Zulveta's Motion of Default judgment filed Jan. 21, 2015.

This case does not apply to none of my civil cases because I have substantial evidences that their defaults were intentional. After they by passed the Entry of default Gallivan White and Boyd P.A., made Appellant Zulveta case eroded out of unlawful activities in and out of court. Their defaults were well deserved.

At said Common court also they introduced Cristina Flores affidavit of perjury.

At Greenville County Common Court Non Jury Coordinator, Clerks Shawn, they tampered with and disappear and no posted inRoster my Motions on time unless I

requested them to do so.

At January 27, 2016 hearing presided by Judge Verdin but Judge Hill case there were improper use of law enforcement officers against a party to a proceeding in court. The Governor of South Carolina Nikkie Haley sent me a letter over this subject relating to initiate a criminal investigation which I will initiate.

Also, The South Carolina Court of Appeals sent me a letter of apologize as result of Judge Hill's Court Reporter Hollie M. Jenkins's obstruction to produce transcript and great deal of source for my dismissal there. Steve Lopez and Shawn tampered and disappear my motions and manuevers in the Court Roster with my motions.

Greenville Library System Vice Chair Hill and Chair Campbell prevented me access to public facility, to internet, block my access to court.

At the SC Supreme Court Disciplinary Counsel Campbell did not process my complaints against Commissioner Beck, attorneys Shull and Philpot, III.

After I released attorney Philpot of his obligation as my attorney he with Commissioner Beck engage in obscure maneuvers of obstruction of justice.

CONCLUSION

Appellant would request all relief requested at the lower court be granted and additional that this court deemed necessary. Hearing to assest damages. Settlement or Dismissal.
