
I am deeply troubled by Respondent's attorney, Yancey McCleod's false and misleading statements. I did not receive the court reporter's (Ms. Hayward) trial transcript until Sept. 6, 2016, after the Labor Day weekend. Mr. McCloud has filed papers with the S.C. Court of Appeals stating that I received the transcript on August 31, 2016. That is completely untrue.

I then filed Appellant's Motion for Extension of time on October 3, 2016, within the thirty (30) days requirement.

Another false and misleading statement is that I received a copy of all of the trial exhibits. There was a great deal of exhibits introduced into evidence at trial. I want to be absolutely sure as to which exhibits were admitted since the exhibits are the basis of my Appeal. I was understandingly relying upon the court reporter for this. 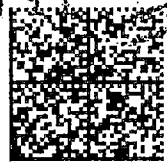
