Appeal Bond and Frivolous motion to dismiss  
state's appeal as we agreed, he need be fired

Dear South Carolina Supreme Court:

Ms. Ashley is or was the case handler/manager handling filings, documents etc in my case at this office the last time I checked. I am complete UNAware of any status of my case and probably want be able to obtain any mail or do any legal work for the next few monthes. I do not have any access to my personal legal material or court LAW library material to prepare for my case, my vision is actually double vision and hard to see. I Am currently in an infirmary, was housed in the Palmetto health trauma unit for being stabbed six times and cut in the back and my head and face was beaten with metal tools etc by 80 inmates after I was mased in the eyes. I may loose one eye but they are very bloody and both damaged. I will be transfered to A institution soon even though its A hit on my head to be killed but I'll be on A lock up still in danger. The point is im sure I want be able to handle my case and Nathan Sheldon has made it clear that he does not want me to get out of prison, and he will work to procedurally default me. He has not been in touch with me and I dont know what has been filed involving my case. Me and my "Power of Attorney" By LAW have sent him everything in my possession

Involving my case and asked him to request all the documents needed to file my Appeal Bond and motion to Dismiss the States appeal. He ignores that but said he will try and get me a Plea; I need my Appeal Bond, motion to Dismiss States Appeal filed and along with it my York County PCR transcripts, S.C. Supreme Court documents, Rule 5 discovery etc needs to be obtained and please contact 601-983-8993 601-983-8993 who is Nikkia Betts and my Power of Attorney. Give her all info to purchase my entire case file from this Agency and York County, sleds office etc because she is going to be handling my case filings and Nathan will be charged with Fraud. Nikkia does not know what happened to me as well, if im still alive to talk to her again because officers are connected at state prisons and they want me killed. No one is helping me here or coming to speak with me. Some one needs to do something. My Amended PCR Application, York County Clerk of Court letters, Charles Brooks letter and A 1-4 Page letter to your Agency along with PCR transcript testimony is grounds for A new PCR hearing on particular issues. Nathan Sheldon is not helping me, someone needs to do something. Please file my Appeal-Bond and motion to Dismiss States Appeal and remove Nathan.

Nathan is the reason my SQE was neglected  
and we had the same conflict of interest  
As Appellate Defense, he now fakes advice  
from them and he was an ineffective per  
Attorney. He should have never gotten appointed  
on this case to handle this appeal. I know

to determine merit. Please help.

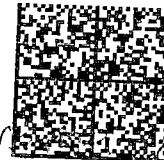
