

Wherefore, Appellant moves for an order granting him additional time and recognizing his request for a transcript fort this matter as timely.

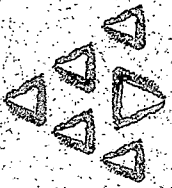

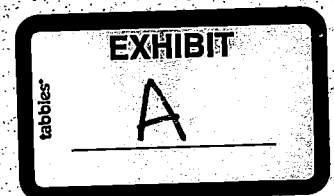

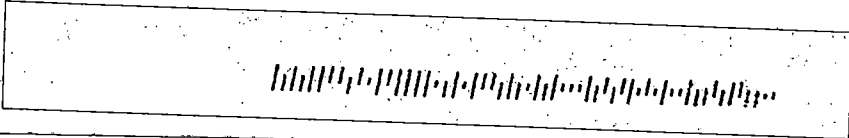
