2. Petitioner-Respondent moved to file a Second Supplemental Appendix on October 17, 2016 to add direct appeal records from the prior court proceedings.


3. Subsequently, our office noticed a clerical error where the Brief of Respondent filed in the Second Supplemental Appendix was the incorrect document.


