I need my PCR Application and Amended Application and all other records as well. PCR counsel absolutely is not doing nothing I need, requests etc. he brags about that.

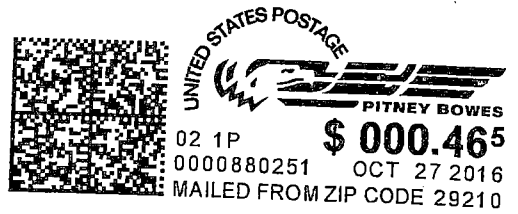
