
NOTICE OF MOTION AND MOTION FOR



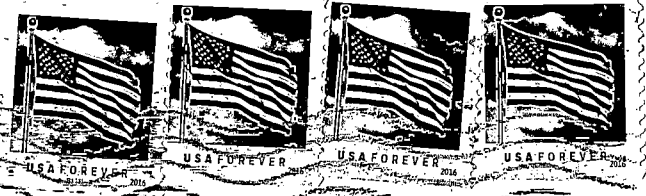
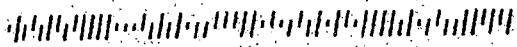
