Thank you for your time and attention to this matter.

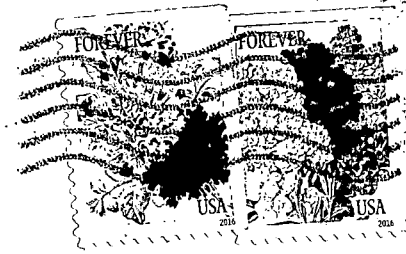
