Counsel for Antwan Zeigler respectfully petitions this Court for an additional 30 days to file the petition for writ of certiorari and accompanying appendix on behalf of her client. In support of this petition, counsel shows:

1. The petition for writ of certiorari and accompanying appendix are due today. The Court has granted one previous extension.
2. Counsel respectfully submits that good cause exists to warrant the granting of an additional extension of time.

3. Specifically, counsel, because of her substantial caseload, has not had the time to complete her client's case, consistent with her duty to provide effective assistance of counsel as guaranteed by the U.S.C.A. 6, 14. *See* Evitts v. Lucey, 469 U.S. 387 (1985) (to be effective appellate counsel must give assistance of such quality as to make appellate proceedings fair). *See also* Ezell v. State, 345 S.C. 312, 548 S.E.2d 852 (2001); Southerland v. State, 337 S.C. 610, 524 S.E.2d 833 (1999); South Carolina Bar Ethics Advisory Committee, Advisory Op. 04-12 (2004) (citing the 2002 ABA maximum caseload standards of 25 appeals). *See generally* Polk County v. Dodson, 454 U.S. 312 (1981); Gideon v. Wainwright, 372 U.S. 335 (1963). Counsel has prioritized her caseload to complete the cases with the largest number of extensions first.


4. Counsel diligently works to keep up with her case load.

6. Counsel makes this request in good faith and not for purposes of delay.


This matter comes before the Court by way of an Application for Post-Conviction Relief filed December 10, 2007. An evidentiary hearing into the matter was convened on December 7, 2009, at the Orangeburg County Courthouse. The Applicant was present at the hearing and was represented by Glenn Walters, Esquire. The Respondent was represented by Mary S. Williams of the South Carolina Attorney General's Office.

At the hearing, the Applicant testified on his own behalf. Also testifying was Crystal Chapman, Esquire ("Counsel"). This Court had before it the records of the Orangeburg County Clerk of Court, the trial transcript, the appellate records, and the Applicant's records from the South Carolina Department of Corrections.

PROCEDURAL HISTORY

Applicant is presently confined in the South Carolina Department of Corrections pursuant to orders of commitment of the Orangeburg County Clerk of Court. Applicant was indicted for Murder (2001-GS-38-0775). Crystal Chapman, Esquire, represented the Applicant. A jury trial commenced

on June 18, 2002, before the Honorable James C. Williams, Jr. Applicant was tried with co-defendant Troy Zeigler. Applicant was found guilty, and on June 21, 2002, Judge Williams sentenced him to forty-five (45) years imprisonment. Both defendants made a motion for new trial. A hearing was held on the motion on July 22, 2002. In a written order dated and filed September 27, 2002, Judge Williams denied the motion.

A notice of appeal was filed and an appeal perfected. The South Carolina Court of Appeals affirmed the conviction. State v. Antwan Zeigler, 364 S.C. 94, 610 S.E.2d 859 (Ct. App. 2005). A Petition for Rehearing was denied on August 26, 2005. The South Carolina Supreme Court denied Applicant's Petition for Writ of Certiorari on January 31, 2007. The Remittitur was sent on February 5, 2007.

In his application for post-conviction relief (PCR), Applicant alleges that he is being held in custody unlawfully for the following reasons:


1. "Ineffective assistance of counsel."
2. "Deficient Performance."
3. "Failure to prepare and trial strategy."

At hearing, Applicant alleged ineffective assistance of counsel in the following particulars:

1. Failure to request mere presence instruction.
2. Juror misconduct.
3. Failure to request severance.

FINDINGS OF FACT AND CONCLUSIONS OF LAW

This Court has had the opportunity to review the record in its entirety and has heard the testimony at the post-conviction relief hearing. This Court has further had the opportunity to observe the witnesses presented at the hearing, closely pass upon their credibility and weigh their testimony



accordingly. Set forth below are the relevant findings of facts and conclusions of law as required pursuant to S.C. Code Ann. §17-27-80.

Ineffective Assistance of Counsel

The Applicant alleges he received ineffective assistance of counsel. In a PCR action, "[t]he burden of proof is on the applicant to prove his allegations by a preponderance of the evidence." Frasier v. State, 351 S.C. 385, 389, 570 S.E.2d 172, 174 (2002) (citing Rule 71.1(e), SCRPC). Where ineffective assistance of counsel is alleged as a ground for relief, the Applicant must prove that "counsel's conduct so undermined the proper functioning of the adversarial process that the trial cannot be relied upon as having produced a just result." Strickland v. Washington, 466 U.S. 668, 104 S.Ct. 2052, 2064, 80 L.Ed.2d 674, 692 (1984); Butler v. State, 286 S.C. 441, 334 S.E.2d 813 (1985).

The proper measure of performance is whether the attorney provided representation within the range of competence required in criminal cases. Courts presume that counsel rendered adequate assistance and made all significant decisions in the exercise of reasonable professional judgment. Butler, Id. The Applicant must overcome this presumption to receive relief. Cherry v. State, 300 S.C. 115, 386 S.E.2d 624 (1989).

First, the Applicant must prove that counsel's performance was deficient. Under this prong, attorney performance is measured by its "reasonableness under professional norms." Cherry, 300 S.C. at 117, 385 S.E.2d at 625 (citing Strickland, supra). Second, counsel's deficient performance must have prejudiced the Applicant such that "there is a reasonable probability that, but for counsel's unprofessional errors, the result of the proceeding would have been different." Cherry, 300 S.C. at

117-18, 386 S.E.2d at 625. “A reasonable probability is a probability sufficient to undermine confidence in the outcome of trial.” Johnson v. State, 325 S.C. 182, 186, 480 S.E.2d 733, 735 (1997) (citing Strickland).

Jury Charge

Applicant asserts that Counsel erred in failing to properly request or object to the jury charge on mere presence. (Tr. P. 681, line 20 – p. 682, line 18.) In State v. Antwan Zeigler, 364 S.C. 94, 105-108, 610 S.E.2d 859, 865-866 (Ct. App. 2005), the charge was found to contain the correct definition for mere presence and to adequately cover the law. Therefore, any failure by Counsel by counsel on this point did not prejudice Applicant.

Juror Misconduct

Applicant further argues that jurors showed sympathy for the victim’s family in violation of the court’s instructions that they not allow themselves “to be governed by passion, by unfair sympathy, by prejudice for or against any party, by public opinion, or any other arbitrary factor.” (Tr. p. 685.) This argument was set forth in the Motion to Impeach Verdict, Take Testimony of Jurors, & for New Trial. The argument at the motion hearing and on appeal focused on whether the jury improperly considered the defendants’ decision not to testify in reaching their verdict. Nonetheless, during the motion hearing, the trial judge considered the one juror’s statement that she was emotional, stating:

... I don’t see anything in there that said she made her decision based solely on emotions after hearing one witness, I didn’t see that in anything that I was given. And so, there’s nothing in [the juror’s] statement that would lead me to believe that she reached her verdict on anything but the state proving its case and the decision being based on the witnesses.

(Motion Hearing Tr. p. 29, lines 9-16.)

To the extent that Applicant frames his allegation as one of ineffective assistance of counsel, I find that Counsel did raise this issue to the trial court. Therefore, I find no deficiency by Counsel in this regard. Post-conviction relief is not a substitute for a direct appeal. Simmons v. State, 264 S.C. 417, 215 S.E.2d 883 (1974). A post-conviction relief application cannot assert any issues that could have been raised at trial or on direct appeal. Ashley v. State, 260 S.C. 436, 196 S.E.2d 501 (1973). However, there is no evidence that had this issue been raised on appeal that the result would have been any different. State v. Zeigler, *supra.*; Rule 606(b), SCRE. See also Tanner v. U.S., 483 U.S. 107, 116-127, 107 S.Ct. 2739, 2745-2751 (1987) (discussing Rule 606(b), FRE, and court policy not to accept testimony of alleged internal jury misconduct in context of allegation of intoxication).

Severance

Applicant asserts that Counsel erred in failing to move for a severance from co-defendant Troy Zeigler ("Troy"). Troy was represented by another attorney in the Public Defender's office. Counsel opined that in retrospect she could have and possibly should have moved for a severance. Nonetheless, Counsel articulated a reasonable basis for proceeding with the joint trial at the time. Where counsel articulates valid reasons for employing a certain strategy, counsel's choice of tactics will not be deemed ineffective assistance. See for example Whitehead v. State, 308 S.C. 119, 417 S.E.2d 530 (1992). Counsel stated that at the time of the trial, she did not see that the co-defendants had any conflicting defense to the point of needing separate trials. Counsel felt that trying the case jointly could strengthen the cases. I find Counsel's reasoning in this decision not outside reasonable professional norms.

Moreover, Applicant has failed to demonstrate prejudice from Counsel's decision not to move for a severance. There is no evidence that a severance was required in this case even if the motion had been made. A motion for severance is addressed to the sound discretion of the trial court. Criminal defendants who are jointly tried for murder are not entitled to separate trials as a matter of right. State v. Kelsey, 331 S.C. 50, 73, 502 S.E.2d 63, 75 (1998). "A severance should be granted only when there is a serious risk that a joint trial would compromise a specific trial right of a co-defendant or prevent the jury from making a reliable judgment about a co-defendant's guilt." Hughes v. State, 346 S.C. 554, 559, 552 S.E.2d 315, 317 (2001). The trial court instructed the jury that guilt of each defendant must be determined separately. (Tr. p. 668, lines 10-19.) Here, Applicant has pointed to no reason a severance would be required. Therefore, I find Applicant has failed to demonstrate prejudice in this regard.

Other Allegations

No other allegations were raised at the PCR hearing. Therefore, any additional allegations are deemed waived because no evidence was presented.

CONCLUSION

Based on all the foregoing, this Court finds and concludes that the Applicant has not established any constitutional violations or deprivations that would require this court to grant his application. Therefore, this application for post conviction relief must be denied and dismissed with prejudice.


This Court advises Applicant that he must file a notice of intent to appeal within thirty (30) days from the receipt of this Order to secure the appropriate appellate review. His attention is also

IT IS THEREFORE ORDERED:

1. That the Application for Post-Conviction Relief must be DENIED AND DISMISSED WITH PREJUDICE; and
2. The Applicant must be remanded to the custody of the Respondent.





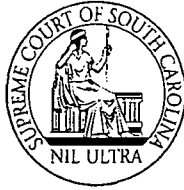

This responds to your letter dated July 14, 2011. This Court can find no record of a notice of appeal being filed with this Court or the South Carolina Court of Appeals in the above matter.

I note that the web based case management system for Orangeburg County does make reference to a notice of appeal. If a notice of appeal was timely served on the counsel for the State but was not filed with this Court, then you or your counsel will need to make a motion to allow the late filing of the notice of appeal. This motion should be accompanied by a copy of the notice of appeal, a proof of service showing that the notice of appeal was timely served on opposing counsel, and a copy of the order(s) on appeal.

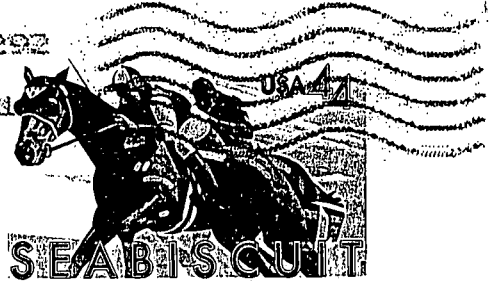
