
RETURN TO RESPONDENT-PETITIONER'S MOTION TO RELIEVE COUNSEL

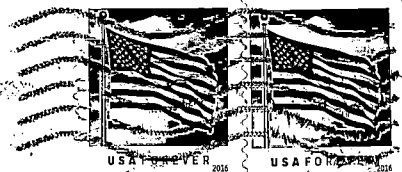
