MOTION FOR AN EXTENSION OF TIME
IN WHICH TO FILE THE PETITION FOR WRIT OF
CERTIORARI AND APPENDIX

Counsel for Samuel Brown respectfully requests an extension of thirty (30) days in which to file the petition for writ of certiorari and appendix in this case. This motion is made pursuant to the Order of the South Carolina Supreme Court dated March 18, 2009. This is a second request for an extension. In support of this request, counsel shows:

1. The petition for writ of certiorari and appendix are due to be served and filed with the Court today.
2. Counsel for Samuel Brown respectfully submits that extraordinary circumstances exist which warrant the granting of an additional extension of time. Given the number of extensions previously granted and the order in which counsel attempts to manage her caseload, counsel hopes that no further extension requests will be required.



Counsel filed Anders brief of appellant and designation of matter with accompanying record on appeal in the case of State v. Steven E. Jennings in the Court of Appeals on October 12, 2016. Counsel filed petition for writ of certiorari to the Court of Appeals in the case of The State v. Arthur Moseley in the Supreme Court on October 11, 2016. Counsel filed Anders brief of appellant and designation of matter with accompanying record on appeal in the case of State v. Lorenzo Ragin in the Court of Appeals on October 4, 2016. Counsel filed petition for writ of certiorari and the accompanying appendix in the case of Lynel Witherspoon v. State in the Supreme Court on September 23, 2016. Counsel had an oral argument in the case of State v. Fred Jack Sanders before the Court of Appeals on September 22, 2016. Counsel filed initial brief of appellant and designation of matter in the case of State v. Keyon Robinson in the Court of Appeals on September 14, 2016. Counsel filed petition for writ of certiorari and the accompanying petition for writ of certiorari pursuant to Austin v. State and accompanying appendix in the case of Michael Ray Elders v. State in the Supreme Court on September 6, 2016. Counsel filed petition for rehearing in the case of State v. Arthur Moseley in the Court of Appeals on September 2, 2016.

4. Counsel makes this request in good faith and not for purpose of delay.

5. Counsel for the Attorney General's office has been informed of this request.




