OUTSIDE OF THE FILING DEADLINES**



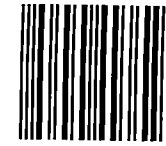

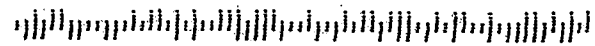
