


Cl Dormitory lockdown since

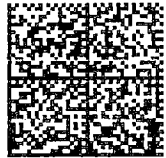
