
ORDER

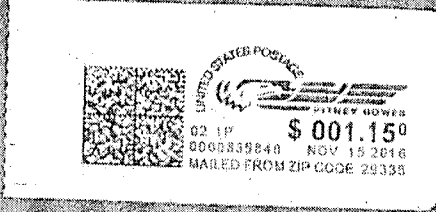
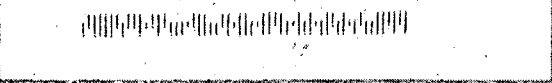
