

NOTICE OF APPEAL

Defendant Robert D. House appeals his conviction and sentence in this case. The defendant pled guilty to a violation of the Uniform Securities Act, CDR #0342 on July 18, 2016 and was sentenced in his absence to ten years in prison on October 24, 2016. This appeal is taken from the order of the Honorable R. Lawton McIntosh dated November 3, 2016, which denied Defendant's motion for reconsideration of sentence.

The issues for appeal are whether the defendant's motion for reconsideration should have been granted based on the following: defendant was sentenced to an extremely long sentence for the charge in which he pled, defendant is chronically ill and expected to require a heart transplant. He was with his physician discussing him being added to the transplant registry the morning of his

sentencing. The defendant is concerned that he will not have the same medical care while incarcerated that he has been receiving from his private physician, and that the possibility of death is a certainty if he does not receive proper care.

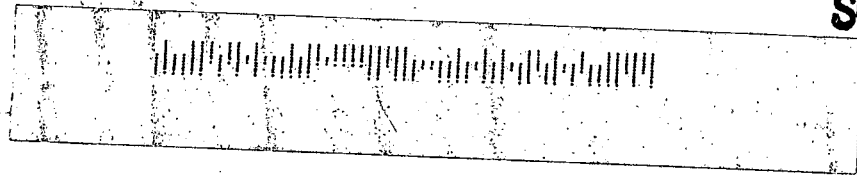
