
**PETITION OF RESPONDENTS FOR EXTENSION OF TIME





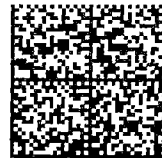
