MOTION FOR COSTS

Respondent City of Columbia Board of Zoning Appeals moves for costs pursuant to Rule 222, SCACR. This Court affirmed the decision of Respondent City of Columbia Board of Zoning Appeals. Op. No. 2016-UP-153. Appellant petitioned for a writ of certiorari, which was denied by order dated November 9, 2016. The remittitur was issued on November 14, 2016. 

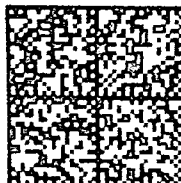
