

Dear Ms. Kitchings:

I am writing to inform you that Counsel for Respondent, Mr. Ben Aplin, contacted my office on Friday, November 4, 2016, and raised to my attention my office's accidental omission of items from the Record on Appeal. I corrected the issue immediately and re-served the Record on Appeal on Mr. Aplin the same afternoon. However, that said, the oversight did result in re-pagination of the Record on Appeal, which meant that Mr. Aplin's office was unable to begin finalization of the citations to the Record in Respondent's Brief until last Friday, November 4, 2016. 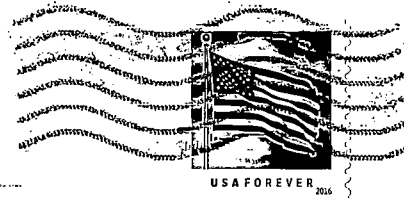
