**MOTION FOR MINOR CHANGE TO APPELLANT'S INITIAL BRIEF**

Upon preparing its Final Brief, Appellant noticed several references to the original trial transcript that require correction, and they are as follows:

1. On page 6 of the Initial Brief of the Appellant, within the second full paragraph and the first full sentence, the reference to p.122, lines 19-25 of the original trial transcript (p. 159, lines 19-25 of the Record on Appeal) is incorrect. The correct reference should be p.182, lines 19-25 of the original transcript (p.219, lines 19-25 of the Record on Appeal). The reason for this change is because the original reference to the transcript was within a different witness's testimony.
2. On page 6 of the Initial Brief of the Appellant, within the second full paragraph and the first full sentence, the reference to p.182, lines 5-7 and 15-18 of the original transcript (p.219, lines 5-7, 15-18 of the Record on Appeal) is incorrect. The correct reference should be p.191, lines 2-9 of the original transcript (p.228, lines 2-9 of the Record on Appeal). The reason for this

- change is because the page/lines cited simply are not the proper pages and lines that correspond to the testimony referenced.
3. On page 6 of the Initial Brief of the Appellant, within the second full paragraph and the last sentence, the reference to p.191, lines 2-9 of the original transcript (p.228, lines 2-9 of the Record on Appeal) is incorrect. The correct reference should be p.194, lines 10-16 of the original transcript (p.231, lines 2-9 of the Record on Appeal). Again, the reason for this change is because the page/lines cited simply are not the proper pages and lines that correspond to the testimony referenced.
  4. On page 6 of the Initial Brief of the Appellant, the second full sentence on the page reads as follows: 'Respondent was referred to Dr. Lieberman by her attorney. (deposition transcript of Dr. Lieberman, p. only twice (transcript, Dr. Lieberman, p. 49, lines 10-12).' This sentence should read as follows: 'Respondent was referred to Dr. Lieberman by her attorney. (Transcript of Dr. Lieberman, p.49, lines 10-12).' The reference to the Record on Appeal will be p. 635, lines 10-12.
  5. On page 4 of the Initial Brief of the Appellant, the last sentence of the second full paragraph, the transcript pages cited will be rearranged to appear in ascending order; currently, the citation lists the transcript pages out of numeric order. This same change would be made on page 14, within the fifth line up from the bottom of the page.
  6. On page 14 of the Initial Brief of Appellant, the sixth line of the first full paragraph on the page references p.281, lines 1-22, p.282, lines 7-25, and p.283, lines 1-25 of the original transcript. The reference should be p.281, lines 1-11, p.282, lines 7-25, and page 283, lines 1-25. The reason for this correction is because the relevant testimony on page 281 ends at line 11; lines 12-25 contain colloquy between the Court and the Jury.

7. On page 14 of the Initial Brief of the Appellant, the last sentence of the first full paragraph references p.345, lines 2-25, pp.346-348, lines 1-6 of the original transcript (p.380, lines 2-25; pp.381-382; p.383 lines 1-6 of the Record). The reference should read as follows: pp.345, lines 2-25; pp. 346-347; p. 348, lines 1-6 (p.380, lines 2-25; pp.381-382; p.383 lines 1-6 of the Record). The reason for this change is to clarify that all lines of pages 346-347 of the original transcript (pages 381-382 of the Record) are being referenced.

Appellant respectfully moves this Court for permission to make the above-requested minor changes within its Final Brief. The Respondent has graciously consented to these minor changes.




