RECORD ON APPEAL


Counsel for Sterling Maybin petitions the Court to allow filing of the Amended Record on Appeal in this case. In support of this petition she shows:

1. Counsel filed the record on appeal on November 16, 2016.
2. On December 1, 2016, Assistant Attorney General, Ranee Saunders, filed a motion to serve and file a supplemental record on appeal after noticing pages designated by counsel were not included in the original record on appeal and that the assistant attorney general inadvertently failed to designate three pages that were cited in her initial brief.
3. After receiving Respondent's filings, counsel reviewed the record on appeal originally filed with this court and discovered that the copy printed and filed with this court was not the version that had been reviewed and approved by counsel. It is missing approximately one-hundred pages of material that should have been included.

4. The amended record on appeal has been prepared and is being filed simultaneously with this petition. It includes the items included in the original designations and the three additional pages requested by Respondent.

5. Assistant Attorney General Rancee Saunders of the South Carolina Attorney General's Office has kindly consented to this request.

WHEREFORE, the undersigned counsel petitions the Court to allow filing of the amended record on appeal.


