
Pursuant to S.C. Code Ann. § 42-17-60 (Supp. 2009), Respondent states the following grounds for the appeal as well as the alleged errors of law:

1. The commission erred in finding and concluding that Appellants/Defendants are entitled to stop temporary total disability benefits (TTD) as of May 4, 2015, in

Finding of Fact #28;

2. The commission erred in finding and concluding that Appellants/Defendants are entitled to a credit for all TTD as of May 4, 2015, in Finding of Fact #29;
3. The commission erred in finding and concluding that Appellants/Defendants are entitled to terminate TTD benefits as of May 4, 2015, and Appellants/Defendants are entitled to a credit against prospective indemnity for all TTD benefits paid from May 4, 2015, through the date the Appellate Panel Order is filed in Conclusion of Law #12.




