

in the foregoing case by thirty (30) days.

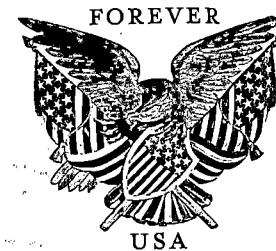
