
**MOTION TO BE RELIEVED AS COUNSEL**

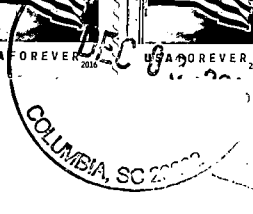
