At the hearing, Appellant placed on the record that he voluntarily withdraws his motions pending before the Circuit Court due to lack of jurisdiction.

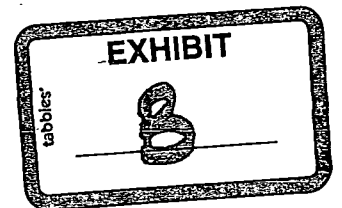
