**PETITION FOR EXTENSION TO FILE
PETITION FOR WRIT OF CERTIORARI

Counsel filed the petition for writ of certiorari and accompanying appendix, and the Anders brief of appellant pursuant to White v. State, in the case of Dwayne R. Clark v. State in this Court on October 15, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix, and the brief of appellant pursuant to White v. State, in the case of Dorothy Harden v. State in this Court on October 8, 2012. Counsel filed the Anders brief of appellant and record on appeal in the case of State v. Dennis Temple in the Court of Appeals on September 28, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix, and the brief of appellant pursuant to White v. State, in the case of Thaddeus Starks v. State in this Court on September 20, 2012. Counsel filed the initial brief of appellant and designation of matter in the case of State v. Debra Newland in the Court of Appeals on September 20, 2012. Counsel filed the record on appeal in the case of State v. Curtis Gerald in the Court of Appeals on September 19, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of Ivan Simmons v. State in this Court on September

14, 2012. Counsel filed the petition for writ of certiorari and accompanying appendix in the case of James Matthews v. State in this Court on September 14, 2012. Counsel filed the Anders brief of appellant and record on appeal in the case of Emilio Craig v. State in the Court of Appeals on September 11, 2012. Counsel had two oral arguments in the Court of Appeals in the case of State v. John Bonner and Ricky Cheeks v. State on September 11, 2012.

3. This request is made in good faith, and not for purposes of delay. Counsel is striving to limit the number of extensions requested. Counsel is attempting to complete the cases with the most number of extensions first.


4. As indicated by her consent below, counsel for the state graciously consents to or does not oppose this request.




