MOTION FOR EXTENSION





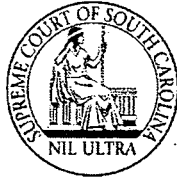
