MOTION TO RECONSIDER FORMA PAUPERIS
REQUEST, SEE ORDER DENIED, etc.

THE COURT DENIED THE APPELLANT'S MOTION TO PROCEED IN FORMA PAUPERIS PURSUANT TO THE EX parte MARTIN, 321 S.C. 533, 471 S.E. 2d 134 (1995), AND THE COURT ISSUED AN ORDER STATING THAT THE APPELLANT MUST PAY THE FILING FEES WITHIN FIFTEEN DAYS OF THE DATE OF THIS ORDER, etc. DATE OF ORDER IS DECEMBER 08, 2016, HOWEVER, THE APPELLANT MOVES THE COURT TO RECONSIDER HIS MOTION TO PROCEED IN FORMA PAUPERIS BASED UPON THE FOLLOWING FACTORS AND PROFFERS THAT ARE THE REALITY OF THE APPELLANT'S CURRENT POSITION AND UNDER THE CIRCUMSTANCES THAT THE COURT MUST BE COMPELLED TO NOT ALLOW THE APPELLANT BEING UNDER A DISABILITY TO DENY HIM THE RIGHT TO HAVE THE COURT TO HEAR HIS GRIEVANCES AND TO HAVE THE COURT ALLOW HIM TO EXERCISE HIS RIGHT TO HAVE HIS RIGHTS TO LIBERTY, PROPERTY AND LIFE RESTORED, CORRECTED BY THE WAY OF ERRONEOUS DENIALS FROM A GOVERNMENT AGENCY AS THE SCDPPTS, THE COURT OVERLOOKED THE FACTS THAT THE APPELLANT IS INCARCERATED AND HAVE NO FINANCIAL ESTATES NOR DOES THE APPELLANT HAVE ANY FUNDS TO PROVIDE FOR FILING FEES TO HIS CASE MATTERS BEFORE THE COURT, AND IT WILL BE A GRAVE INJUSTICE COMMITTED BY THE COURT TO DENY THE APPELLANT FROM HAVING ACCESS TO THE COURT IN HIS APPEAL CASE MATTER.

THE APPELLANT HAVE PROVIDED TO THE COURT A STANDING RECORD OF HIS E.H. COOPER TRUST FUND ACCOUNT. AND IT REFLECTS THE RESULTS OF POSSESSION OF NO FUNDS, etc.
