Considering the above authorities all taxable costs for all aspects of this Action in all stages of the appellate process should properly be borne by Appellant/Plaintiff:



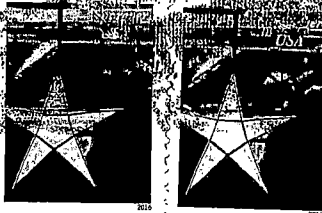
