I.



The parties have now resolved the case.


WHEREFORE, Appellant requests that the Court remit the case to the Court of General Sessions for York County so that the indictments can be dismissed.



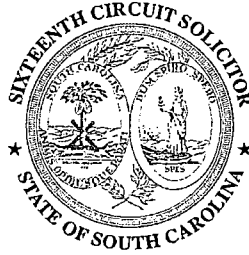
