221(A) S.C.A.C.R. ON the following grounds:



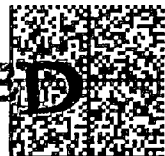
