the following errors/facts:

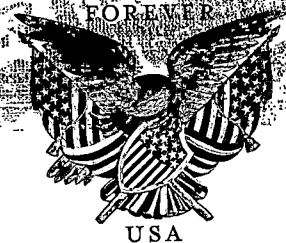
- ① My personal conflict with Solicitor Staff MRS. WACKER

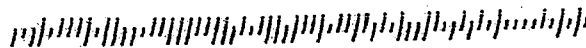
