
**COUNSEL GEORGE R. McELVEEN, III's RETURN TO  
APPELLANT'S MOTION TO RELIEVE COUNSEL**

In response to the court's request for a return to Appellant's letter dated October 11, 2016, undersigned counsel would state as follows:

I represented Mr. Chick on the charges underlying this appeal. The matter was resolved by plea on September 22, 2016. Although the pleas was "as indicted", other charges were dismissed in consideration of the plea. Mr. Chick did not consult with me regarding further proceedings. Mr. Chick did not ask or direct me to file a Motion for Reconsideration, Notice of Appeal, or otherwise initiate further proceedings. I never, at any time, considered myself as having been retained for such a purpose, and I do not believe that such proceedings would have had merit.

To the extent that Mr. Chick's aforementioned letter represents a motion to relieve counsel, I certainly have no objection. However, never having undertaken to

represent Mr. Chick in this regard, I believe that Mr. Chick's filing should be deemed  
pro-se.


