
PROPOSED INTERVENOR'S MOTION FOR EXTENSION OF TIME TO FILE



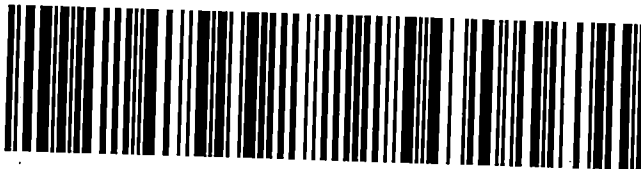
