I then left the location where I purchased the Crack and went straight back to the confidential location to meet back with agents. Upon returning I turned over the Crack to agent McClure and was debriefed and searched again with negative results.

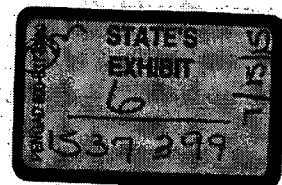


