


I have received a copy of your request for a transcript in the above-referenced matter from Court Administration on December 16, 2016 dated November 8, 2016.

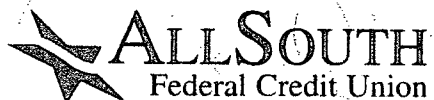
