
Honorable Ms. Kitchings,

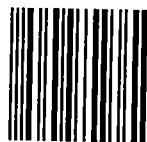
