MOTION FOR AN EXTENSION OF TIME


1. The petition for writ of certiorari and appendix are due to be served and filed with the Court today.

State in the case of Samuel Brown v. State in this Court on November 23, 2016. Counsel filed initial brief of appellant and designation of matter in the case of State v. David Wilkins Ross in the Court of Appeals on November 16, 2016. Counsel filed the petition for writ of certiorari and the accompanying appendix in the case of Ricky D. Cheeks v. State in this Court on November 10, 2016.


4. Counsel makes this request in good faith and not for purpose of delay.


