**APPELLANT'S MOTION FOR AN ENLARGEMENT OF TIME**

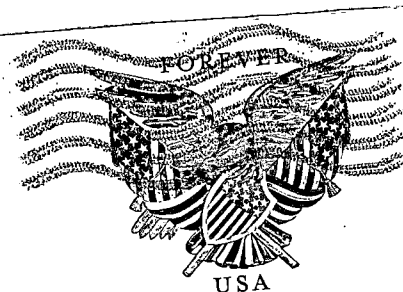

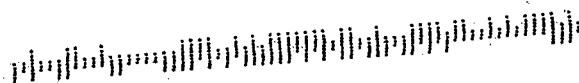
