MOTION TO RECONSIDER

From Court Order, January 12, 2017 signed by James E. Lockemy

RE: *“Appellant shall serve and file a supplemental record on appeal, which includes the following documents: (1) April 30, 2015 to May 2, 2015 School Board Hearing Transcript with all attached exhibits;...”*

Why Reproduce Blank Pages?

“Exhibits”: One hundred-two (102) pages of Respondent’s exhibits were blank pages from a Walmart ‘grade book’. The authentic ‘grade book’, provided by the District (Respondent) and used by Appellant, was confiscated and withheld until after the Hearing.

This exhibit would add 1836 empty pages to the *“supplemental record.”* These pages serve no purpose and should be omitted.

Why Reproduce Irrelevant Pages?

“Transcript with Exhibits”: This is 744 pages. Fewer than 100 pages have been designated for use in this case, wasting at least 644 pages per unit, and translating to about 11,592 wasted pages. Since the court restricts a volume to 250 pages this would result in over 50 unnecessary volumes for the court to manage.

Rule 210 (c)

“Where a portion of a page of the trial transcript, or a page of an exhibit or document, is to be included in the Record on Appeal, the entire page shall be included.” This clearly indicates that not all pages of a transcript nor all pages of exhibits need be included.

Request


