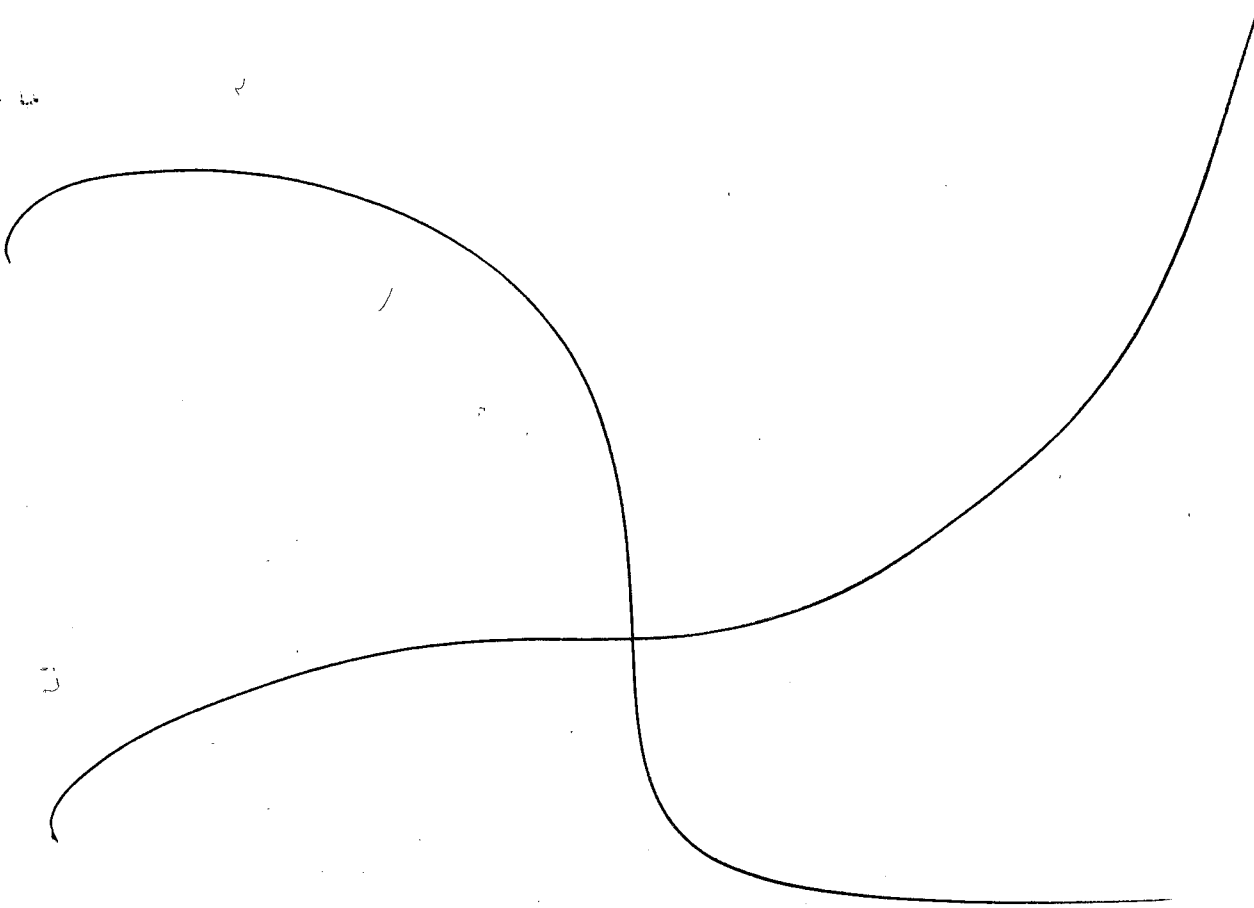
1. DEAR MS. ALLEN,

2. CAN YOU PLEASE CALL, email another Memorandum

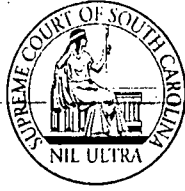
to Ms. Holmes, so my Appeal in the Above captioned case can proceed?
