

Counsel filed the Anders brief of appellant and Record on Appeal in the case of State v. Brandon Adams in this Court on November 23, 2016. 3. This request is made in good faith, and not for purposes of delay.


4. As indicated by his consent below, counsel for the state graciously consents to or does not oppose this request.




