The appellant, Trey Brown, respectfully petitions this Court for an order extending the time to file his initial reply brief until Friday, January 27, 2017.


This is the first request for an extension to file the reply brief. An extension is necessary because of counsel's other professional obligations. This request is made in good faith and not intended for delay.



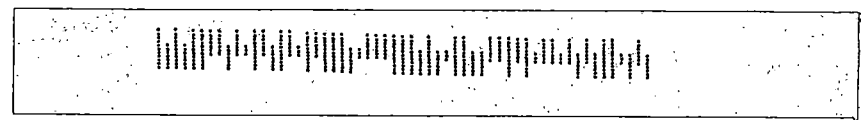
