I am confused and have called and asked after sending in the MOTION TO HOLD TIME IN ABEYANCE TO CONSIDER SUBJECTS TO BE INCLUDED IN THE APPEAL and the AMENDED Motion about whether the exhibits that were included in it for the Court to consider were approved or not. I never saw a ruling and in Mr. Baxley's reply he wanted everything removed, but again there was no ruling either way.

Does this mean I have to do another motion that will be for and including:

- 1) newly discovered radiological errors and treatment,
- 2) newly discovered criminal activity by doctor and adjuster (Sept 2016),
- 3) FCE complete report obtained from Georgetown hospital to prove that the Defendants' exhibit was tampered with and missing injury page 7 when it was put into evidence at the court,
- 4) Proposed orders from all of the Commission Orders (these actually come from the Commissioner making the ruling instructions to winning attorney who writes up the Order which is supposed to include the Proposed Order and whatever that attorney can get away with,
- 5) Transcript of Commission Panel which was just transcribed from audio on January 6, 2017 (when I picked up a copy of my file, I had been told there was none and it must not have been recorded, but received a copy of an email from Mr. Baxley requesting that transcript the day before)
- 6) HIPPA rights violations filed as two complaints with the Federal government for investigation
- 7) WCC updated form R08

- 8) Emails which prove collusion of adjuster to prevent injured worker from working under doctor's restrictions and why employer refused them and accommodations filled out by their treating doctor,
- 9) emails or documents that I had stated were there during the hearing, but I could not produce them while Mr. Baxley was grilling me with unknown questions. (If I had the questions prior and had known Upon Mr. Baxley's testimony I was "Noncredible", I could have found the paperwork to verify my testimony as truthful),
- 10) a body part authorization form proving the employer only authorized certain body parts along with a physical therapy evaluation that states why back and hip were not evaluated because employer denied authorization, and
- 11) there may be something I have left out , trying to get this in the mail to you.

So the gist is, I need to know what to do about the abeyance motion already done that I think included everything, but the new transcript.

If I did not do it right or word it right, if I have to do a new Motion for the above to get them considered to put in my appeal so they won't be denied? And what does it mean when the Court doesn't rule on something like the Abeyance Motion? Does it mean I can include or not? Mr. Baxley in his motion to strike this material said it was not provided on a new material motion.

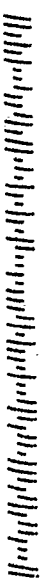
