

and she told me if i didnt plead guilty i would get life

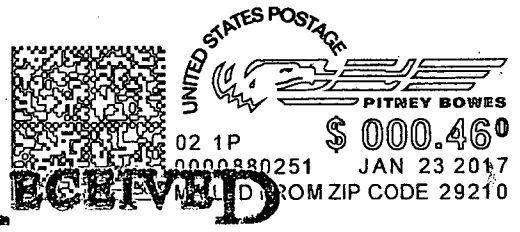
My whole situation is both of this guys younger brothers

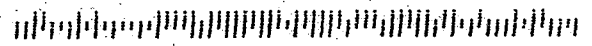
