MOTION TO CORRECT/AMEND RECORD

I, Loushonda Myers, now submits to this court to have certain facts Judicially Noted, and to have the Record properly corrected. I have been ordered to submit a Supplement to the Record on Appeal by order dated January 12, 2017. This Supplement is to include a Notice of Appeal dated stamped September 9, 2014 at 12:30 pm; a copy of the State's Memorandum in Support of Rule to Show Cause; and a certificate of service for the Rule to show Cause. I have submitted a Supplement to the Record on Appeal for fear of my Appeal being dismissed- even though substantive issues have arisen.

I have recently contacted the Clerk of Court's Office in Georgetown County on January 24, 2017 and there is no record of a Notice of Appeal submitted September 9, 2014 at 12:30 pm.

The copy that has been submitted with the Supplement to Record on Appeal has been provided by the States Attorney General's Office. There being no record found in the Georgetown County Clerk's Office leads me to question the inclusion of this document(s) in the Record on Appeal.


In addition, I have been ordered to produce and/or include documents already filed in the first Record on Appeal. Beginning on page nine of the Record on Appeal filed in this Court is the State's Memorandum. I should not have been burdened by reproducing these documents at my expense and burden when they have already been included.

Also, I was never served nor was I ever given a Certificate of Service for the Rule to Show Cause, and to my knowledge and belief there is no Certificate of Service only an Order for me to appear which is included in the Supplement. I have kept all original copies in regards to the Rule to Show Cause and a Certificate of Service does not exist, there is only an Order.

Therefore, I am respectfully demanding that the Record be amended and/or corrected to show that (a) the Georgetown Clerk of Court Office does not possess any Record of the Notice of Appeal for September 9, 12:30 pm; (b) the State's Memorandum has already been submitted; (c) there is no certificate of service for the Rule to Show Cause-only an Order to appear.

I am also respectfully demanding pursuant to Rule 210 (c), (a) due to the fact that there is no record of the Notice of Appeal being submitted on September 9, 2014 in the lower court; and due to the fact that I was never served no given a Certificate of Service for the Rule to Show Cause, they be removed from the record, as such no Supplement to the Record on Appeal is needed; (b) an order specifying these facts and correcting the Record in this Court; (c) this matter be stayed pending the outcome of this motion.


