THAT IS CURRENTLY IN THE SOUTH CAROLINA DEPARTMENT OF  
CORRECTIONS. I WAS SENTENCED TO 15 YEARS ON JANUARY 12,  
2017 BY THE HONORABLE JUDGE STILLWELL. ON THE SAME DATE JANUARY  
12, 2017 MY COURT APPOINTED ATTORNEY LAUREN TAYLOR ASKED FOR  
A DIRECT APPEAL (OR SOMETHING SIMILAR TO AN APPEAL) ON THE  
FOLLOWING CHARGES OF ARMED ROBBERY + ASSAULT + BATTERY IN  
THE 1<sup>ST</sup> DEGREE. CASE NO(S) 2014-GS-23-008396 and 2014-GS-23-008398  
AND WAS DENIED & DO UNDERSTAND THAT ALL DEFENDANTS HAS

AND IS NOT ALLOWED ANY WRITTEN MATERIAL SUCH  
AS PENS ON YOUR PERSON NOR IN YOUR CELL UNTIL YOU  
HAVE BEEN THERE 3-7 DAYS, AND CANT WRITE OR UTILIZE  
ANY MATERIAL UNTIL YOUR ASSIGNED REC DAY, WHICH IS  
EVERY OTHER DAY AFTER YOU'VE BEEN THERE ON "SHOE" STATUS  
3-7 DAYS. AND THATS OUTSIDE YOUR CELL AT A TABLE.

I'M ASKING OUT THE KINDNESS OF MY HEART: CAN YOU  
PLEASE TAKE THIS LETTER INTO CONSIDERATION, AND GRANT  
ME THE NECESSARY TIME/EXTENTION, SO THAT I CAN  
WORK ON APPEALING MY CASE? THANK YOU
