Dear Alan:

I am in receipt of your letter of January 31<sup>st</sup>, which I attach. You make complaint of certain information contained in the Record on Appeal in the above appeal which was served by mail of December 9<sup>th</sup>, 2016. You make demand for the refiling or redaction of that information.

First, I am largely unable to identify the information complained of. If I read correctly, pages 45 and 63 are Exhibit Covers, page 65 is the first page of my client's "Defendants Complaint", pages 185 and 186 are, indeed, unredacted pages with checks by my client to yours having what I presume to be his former bank account number on the cover page.

At a glance, I assume your problem, other than the account number, is with documents showing your client's addresses over time.

My problem with your complaint is that the documents as filed with the Court of Appeals are in the same state as when they were submitted by yourself at trial; in short, you did not redact the information you now require me to redact. I do not believe I have the ability or duty to act on documents that were left in this state at trial. I am forwarding your letter and mine to the Clerk of the Court of Appeals with a request for her position on this matter. Obviously, I will take whatever action the Clerk requires.


Dear Mr. Foster:

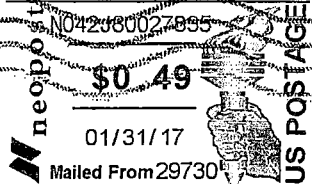
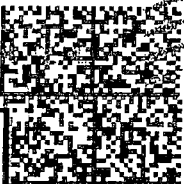
