If you require a deposit for this, please let me know as soon as possible, and I will remit.

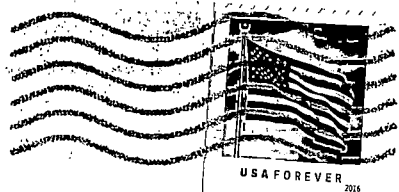
