
**MOTION FOR AN EXTENSION TO FILE INITIAL BRIEF AND DESIGNATION





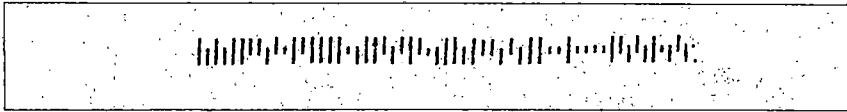
